This position is responsible for the stocking, setup, and maintenance of the condiment stations. This position will also assist in the storage of all products, as well as maintenance and cleaning of foodservice equipment. Prior experience within a foodservice environment is preferred.

Rotates inventory practicing FIFO (first in, first out)
Maintains cleanliness and organization of the condiment room
Set-up and tear-down of condiment carts
Follow and receive direction from supervisors and managers
Assist with any warehouse functions
Assist the concessions supervisors in any functions
Assist with cleaning of foodservice equipment
Other assigned duties
